A RESOLUTION OF THE BOARD OF FIRE COMMISSIONERS OF THE ARGYLE FIRE DISTRICT, AN INDEPENDENT SPECIAL DISTRICT IN WALTON COUNTY, FLORIDA, ADOPTING THE TENTATIVE BUDGET FOR FISCAL YEAR 2025-2026 (FY26); PROVIDING FOR AN EFFECTIVE DATE.
